Dear Members of the Bar,

As a result of the November 2010 General Election, there are many upcoming changes within the Eighth Judicial District Court, Civil, Criminal and Family Divisions. **Attachment 1** is a list of the new District Court Judicial Departments with the appropriate contact information for staff.

As the Court facilities are currently at capacity with regard to Judicial Chambers and Courtrooms, the following is a summary of the Interim Judicial Chamber locations of the Eighth Judicial District Court Departments. This location plan will likely remain in effect until the remodel project at the RJC is completed, estimated to be near the end of the second quarter of 2012:

### **Regional Justice Center Chambers – 200 Lewis Avenue, Las Vegas, NV 89155**

Civil/Criminal Division Departments: 1 – 24; **excluding Civil Departments 19 & 20.**  
Family Division Departments: H & M .

### **Family Court and Services Center Chambers – 601 N. Pecos Road, Las Vegas, NV 89101**

Family Division Departments: A – R; **excluding Family Division Departments H, M, S & T.**

### **Phoenix Building Chambers – 330 S. 3<sup>rd</sup> Street, Las Vegas, NV 89101**

Civil Division Department: 20.  
Civil/Business Court Division Department: 25.

### **Complex Litigation Center Chambers – 333 S. Sixth Street, Las Vegas, NV 89155**

Civil/CD Division Department: 19.

### **Clark Building Chambers – 301 E. Clark Avenue, Las Vegas, NV 89101**

Civil Division Departments: 26 – 32.  
Family Division Departments: S – T.

As the Clark Building is currently not accessible to the general public, all individuals needing to conduct business with the Judicial Departments chambered in the Clark Building will need to coordinate with the appropriate department to acquire access and escort to the Judicial Chambers area. There will also be updated Judicial "Drop Boxes" at the appropriate facilities for correspondence that needs to be conveyed to and from respective departments. For the Clark Building, specifically, the drop boxes will be located just inside the lobby of the Clark Building Main Entrance; accessible without having to go through the security station.

Please be advised that District Court Department Nine (9) now has chambers on the 10<sup>th</sup> floor, and will be utilizing Courtroom 14A for all matters. Family Division Department H now occupies the chambers area behind courtroom 14A and will be utilizing Courtroom 14A in coordination with District Court Department Nine (9). Also, District Court Civil/Criminal Division Department Fifteen (15) is now occupying RJC Chambers & Courtroom 11D. District Court Department Twenty (20) occupies chambers room 100A & courtroom number 116, on the 11<sup>th</sup> floor of the Phoenix Building.

Attachment 2 is the schedule of the Courtroom usage for the Civil/Criminal Division. The schedule shows the courtroom sharing plan that will take effect beginning January 3, 2011. Appropriate signage will be displayed within the Court Facilities to reflect these changes, and the Infax Calendar Display Systems will also identify where matters are being heard. As reflected on Attachment 2, there will be consistency with the department motion calendars, however, lengthy hearings or trials are subject to relocation during the course of the matter.

All of the contact information for the new Judicial Departments, and changes to the existing departments will be updated in the next edition of the Nevada Legal Directory, published by the *Nevada Legal News*, in March of 2011.
