<b>4.060 Fees for Justices of the Peace</b>	<b>Fee</b>
1. Except as provided in Subsection 2, each justice of the peace shall charge and collect the following fees:	
(a) On the commencement of any action or proceeding in the justice's court, other than in actions commenced pursuant to Chapter 73 of NRS, to be paid by the party commencing the action: <i>(General Civil Cases)</i>	
If the sum claimed does not exceed \$1,000.00	\$49.00*
If the sum claimed exceeds \$1,000.01 but does not exceed \$2,500.00	\$71.00*
If the sum claimed exceeds \$2,500.01 but does not exceed \$4,500.00	\$121.00*
If the sum claimed exceeds \$4,500.01 but does not exceed \$6,500.00	\$146.00*
If the sum claimed exceeds \$6,500.01 but does not exceed \$7,500.00	\$171.00*
If the sum claimed exceeds \$7,500.01 but does not exceed \$10,000.00	\$196.00*
In all other civil actions/Landlord Affidavits of Complaint	\$49.00*
(b) For the preparation and filing of an affidavit and order in an action commenced pursuant to Chapter 73 of NRS: <i>(Small Claim Cases)</i>	
If the sum claimed does not exceed \$1,000.00	\$46.00*
If the sum claimed exceeds \$1,000.01 but does not exceed \$2,500.00	\$66.00*
If the sum claimed exceeds \$2,500.01 but does not exceed \$5,000.00.	\$86.00*
(c) On the appearance of any defendant, or any number of defendants answering jointly, to be paid by him or them on filing the first paper in the action, or at the time of appearance:	
In all civil actions <i>(Answers and Tenant Affidavits)</i>	\$33.00*
For every additional defendant, appearing separately.	\$27.00*
(d) No fee may be charged where a defendant or defendants appear in response to an affidavit and order issued pursuant to the provisions of Chapter 73 of NRS.	
(e) For the filing of any paper in intervention.	\$27.00*
(f) For the issuance of any writ of attachment, writ of garnishment, writ of execution, or any other writ designed to enforce any judgment of the court	\$6.00
(g) For filing a notice of appeal, and appeal bonds	\$12.00

(h) For issuing supersedeas to a writ designed to enforce a judgment or order of the court.	\$12.00
(i) For preparation and transmittal of transcript and papers on appeal.	\$12.00
(j) For celebrating a marriage and returning the certificate to the county recorder	\$50.00**
(k) Judgment by Confession:	
Entering (first appearance in action)	\$27.00*
Entering (subsequent to first appearance).	\$6.00
(l) For preparing any copy of any record, proceeding or paper, for each page.	\$0.30
(m) For each certificate of the clerk, under the seal of the court.	\$3.00
(n) For searching records or files in this office, for each year.	\$1.00
(o) For filing and processing each bail or property bond.	\$40.00
District Court Appeal Filing Fee (Due upon filing of Appeal).	\$47.00***
TPO - Harassment in Workplace - Security (From Employer)	\$100.00
Demand for Jury Trial Deposit	\$280.00
