23 Katz: Yeah, how ya doin'?

24 (Inaudible conversation)

25 Katz: Yeah.

01 Riccio: He sold a bunch of your stuff

22 Simpson: Relatively late last night _____.

23 Riccio: Yeah. One guy...

24 Simpson: Worn out.

25 Riccio: ...that one guy from millionaire high

01 Roller ___ that invited me. Do you know that

02 guy...Lowell? Yeah. He was like hey, tell

03 OJ we'll go party blah, blah, blah.

04 Katz: Yeah.

05 Riccio: You must get that all day long.

06 Simpson: Yeah but _____ get to know like tonight or

07 if I'm at, I'm at the bars. The clubs. These

08 guys they can spend they money. (Laugh)

09 Simpson: And I don't even spend money. Was nice

10 bein', not to, ya know, uh, and not to spend

11 350 dollars for a bottle of liquor.

12 Riccio: Uh, this guy did...this guy.

13 Katz: Yeah.

14 Riccio: This guy.

21 grand a night just drivin' people to strip clubs.
22 Yeah. Yeah. I love this town. (Laughs)

24 Katz: Yeah. I used to be in Long B...I grew up
25 in Long Beach.

20 Uh. And I called the... your house. They were

21 gonna give it to me 47 percent off the cover price

22 of the book. If I brought a hundred 'em. 40

23 percent, 7 percent ___ cover book. All \$13.00

24 somethin' like that. And, uh, but they're sayin',

25 the warehouse is sayin' they don't even have 'em yet.

01 So I'm thinkin'
02 they're thinkin' it's gonna be another week or two before
03 it comes out.

04 (Inaudible conversation)

05 Riccio: So I mean, I ____.

06 (Inaudible conversation)

07 Riccio: He, he sells ____.

08 Simpson: They had a big pre-order on Barnes and Noble ____.

23 already askin' me. And I told 'em I can get it done.

24 Katz: Yeah.

25 Riccio: So, so I, I think maybe ____.
