

01 The following is the transcription
02 of a surreptitious recording of a conversation
03 between Simpson and Riccio. (File #8)

04 Riccio: Tom

05 Simpson: Hey

06 Riccio: Uh.....ni., night of my nightmares

07 Simpson: Laughing

08 Riccio: People are coming at me in the morning after it was all
09 done. O.J. broke into my room with a gun. And then
10 there was media all out in front of the place. I tried to go
11 out there and tell um, what happened then.

12 Simpson: I saw you, I saw you I was real happy with what you
13 did, and then you noticed they don't show you no more
14 because they want to keep that story

15 Riccio: It, it you know what, I've had Geraldo call me five times.
16 Larry King wants me to come on.

17 Simpson: Yeah

18 Riccio: I, I mean I wanna tell the truth juice. I love you man but,
19 you know, uh, it, uh, all these people are coming down on
20 me for working with you. Including my, people at my
21 auction house. But, I mean it really sucks. People don't
22 understand you know what, what we were trying to do.
23 We were trying to, trying to get bad people. You know
24 what I mean?

25 Simpson: Yeah, yeah. But, they will. You know it's the first

19 there, I don't know weather you saw it. I'm thinking maybe

20 you didn't see it. Probably didn't see it. But there was a

21 guy there with a gun.

22 (Talking over each other)

23 Simpson: I _____ with a gun

24 Riccio: I know, I know you didn't see it. I know you didn't see it.

25 Simpson: I didn't see it

18 Simpson: I told everybody to back off.

19 I said back off man and

20 then I talked to the guys

21 Riccio: Right

22 Simpson: (Inaudible)

23 Riccio: Right

24 Simpson: _____ anybody _____

25 Riccio: Maybe it was a toy gun. (Cell phone had sound of in

02 Simpson: Well whats his name told me, you know I mean.

03 What's his name the big guy told me they came in acting

04 like they were FBI. You know so, I didn't know if they were

05 _____ I heard that they said somebody

07 Riccio: Right

08 Simpson: I was like, like

09 Riccio: Well, well I, I'm not gonna lie to you and I anit gonna lie to

10 anybody. I did one guy . They're saying they saw a lot of

11 guys. I saw one guy with a gun.

12 Simpson: _____

13 Riccio: So

14 Simpson: The guy that walked in before me.

15 Riccio: I don't know who he was. I don't want to know who he

16 was. I don't know I'm saying

17 Simpson: He didn't point it at anybody did he?

18 Riccio: I, he sorta weaving it around, and you know, and that's the

19 big thing, I mean if we just went there to retrieve some shit

20 like we planned.

21 Simpson: That's what I said. I didn't see any, I didn't

22 see that. I didn't tell anybody to bring a gun.

23 And I didn't see a gun. But maybe I don't know.....

24 (Talking over each other)

25 Riccio: Those, those fuckers would have just given

01 the stuff back and it would have been

02 the end of the story if no one waved a gun around.

03 That's the whole thing.

04 That's the whole thing. But,

05 Simpson: I told them just to do that.

06 (Both talking)

07 Riccio: Yeah

08 Simpson: Maybe he was trying, behind me trying to act

09 like something.

10 Riccio: Right

11 Simpson: But, I

12 Riccio: No, I

13 Simpson: That, that would be wrong.

14 Riccio: No,

15 Simpson: That would be really wrong

16 Riccio: No, I, I know, I could tell you didn't, you didn't

17 see anything. But, I'm just telling ya, I'm

18 letting you know.....

19 Simpson: But, they walked in before me, and then

20 I came in and told them to back off.

21 By the back.

22 Riccio: Right

23 Simpson: And once they were behind me

24 Riccio: Yeah

25 Simpson: I talking to the guys in front of me

02 Simpson: These guys are behind me, so I didn't un,
03 none of that.

08 to do, he kinda wanted it to go away. He's like me.

10 Riccio: You're out our your mind. You think Beardsley
11 wants to see this go away? He was on the phone

14 the police were coming.

15 Simpson: I know you said _____

16 Riccio: You, you, you, think he's your friend? You think that guy,
17 you're gonna see something. You think he's your friend?

18 Simpson: _____ not my friend

19 Riccio: What?

20 Simpson: No he's not my friend.

21 Riccio: You're gonna see how he's not your friend when it's all
22 done. You know. I, I mean , that, that guy...

23 Simpson: Anyway

24 Riccio: That guy will stab you in the back in a second. You know.

25 Simpson: Anyway, I uh, I uh, (cell phone in coming call

01 sound). I didn't talk to anybody. I talked to the guys

02 Riccio: I, I said that

03 (Talking over each other)

04 Riccio: Listen, I told everybody you were just there to get

05 your stuff back. You were mad like anybody would

06 be mad that you're violated,

07 (cell phone incoming call sound)

08 and your stuff stolen. And all that kinda stuff.

09 Hold on one second I have a friend coming, and

10 they may need directions. Hold on one second.

11 Riccio: (Clicks over to incoming phone call) Hello

12 ? Hello is Irene Riccio there?

13 Riccio: Um no not right this minute, who's this?

14 ? Uh, this is Markish Jenelle. I'm calling from

15 Shadow Works. We, we put an add out on Craig's list for

16 extras. And we wanted to find out if she had any other

17 head shots, and if she could send them, so we could, so

18 we

19 Riccio: I'll let her, I'll let her know that you called.

20 Markish Great, appreciate that.

21 (clicks back over to previous phone call)

22 Riccio: Hello

23 Simpson: Yeah

24 Riccio: Um, anyway

25 Simpson: So you did your interview with the cop's and all that?

01 Riccio: I have, all night they had me, they wouldn't let me,
02 then they, then they took my fricken phone.

03 They confiscated my phone. My new, my new I Pod phone.

04 Simpson: Oh

05 Riccio: Cause I took a picture of Al with,
06 with this, with the crap before everybody came.

07 And Al told um.

08 (Cell phone in coming call sound)

09 So they took my phone.

10 Simpson: Yeah

11 Riccio: Alright so I just wanted to tell you, I know
12 you didn't know

13 Simpson: Lets just keep in touch, lets keep in touch.

14 Riccio: Alright, I, alright

15 Simpson: I know Beardsley kinda wants uh (cell phone in
16 coming call sound) their word against uh, us.

17 Riccio: Alright man, I'll keep in touch with you. When you leaving
18 town?

19 Simpson: Uh, next week.

20 Riccio: Alright, does that

21 Simpson: Are you still in town?

22 Riccio: No, I, I gotta get home, I had business to do. I, I, I, uh,
23 you know, I have a million people wanted to talk to you too.

24 But, that's up to you man. They're asking for your

25 number and shit, and I don't give em, out, I don't, I'm not
