

**We will post a list of cases on the County and NV State websites once the calendar is finalized**

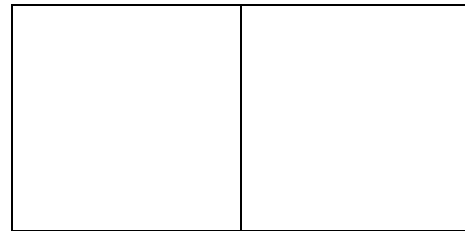
