CLERK OF THE COURT IN THE MATTER OF Inter-Departmental Case Transfers and Assignments

WHEREAS Rule 1.30 of the Rules of Practice for the Eighth Judicial District Court of the State of Nevada ("EDCR") charges the Chief Judge of the Eighth Judicial District Court with various responsibilities, such as supervising the administrative business of the court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed, and otherwise facilitating the business of the court; and

WHEREAS the Chief Judge has determined that a redistribution of cases among certain Departments in the Eighth Judicial District Court Civil/Criminal Division is necessary to improve the efficiency in the adjudication of its cases:

IT IS HEREBY ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 400 cases aged 48 months or less from Department 27's open civil caseload shall be randomly selected, transferred to, and equitably distributed among Departments 1, 4, 14, 26, 28, 30, 31 and 32.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 120 open civil cases in Department 11 that are designated as "Business Matters" pursuant to EDCR 1.61(a) shall be randomly selected, transferred to, and equitably distributed between Departments 25 and 27.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that all open criminal cases in Department 9 shall be transferred to Department 11.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that all open criminal cases not designated as Specialty Court cases, shall be transferred from Department 7 to Department 9.

IT IS FURTHER ORDERED that an updated Criminal Caseflow Model reflecting the changes to the tracking system as a result of the aforementioned case transfers be attached as an exhibit to this order.

IT IS FURTHER ORDERED that the aforementioned transfers, assignments and track changes shall take effect on January 22, 2013.
