WHEREAS, Eighth Judicial District Court Rule ("EDCR") 1.33 (b) provides that the Chief Judge must assign Judges of the District to the Business Court Division;

WHEREAS, EDCR 1.61 provides for the assignment of business matters;

WHEREAS, by way of Administrative Orders 06-06, 09-09, 11-03, 13-02, and 15-11, the Court has made certain reassignments pertaining to the Business Court Division, with current Business Court filings being randomly assigned to Departments 11, 13, 25, 27 and 29; and,

WHEREAS, it has become necessary to make further case and departmental reassignments in the Business Court Division.

IT IS HEREBY ORDERED, pursuant to EDCR 133 (b) and EDCR 1.61, that all Business Court matters currently assigned to Department 29 shall be reassigned to Department 15.

IT IS FURTHER ORDERED, pursuant to EDCR 133 (b) and EDCR 1.61, that Department 15 shall replace Department 29 in the Business Court Division.

IT IS FURTHER ORDERED, pursuant to EDCR 133 (b) and EDCR 1.61, that the Business Court Division shall consist of Departments 11, 13, 15, 25, and 27.

IT IS FURTHER ORDERED, pursuant to EDCR 133 (b) and EDCR 1.61, that all new Business Court cases shall be randomly assigned as follows: 1/4 to Department 11, 1/4 to Department 13, 1/8 to Department 15, 1/8 to Department 25, and 1/4 to Department 27.

IT IS FURTHER ORDERED, pursuant to EDCR 133 (b) and EDCR 1.61, that Business Court cases where all Business Court Judges are peremptorily challenged or otherwise recuse shall be assigned to the Chief Judge.

IT IS FURTHER ORDERED, that Court Administration shall publish on the Court's website a list of those Business Court cases affected by the reassignment.

IT IS FURTHER ORDERED, that this Administrative Order shall take effect on March 14, 2016 and shall continue until modified or rescinded.
