Administrative Order: 17-12

**WHEREAS**, Rule 1.30(b) of the Rules of Practice for the Eighth Judicial District Court of the State of Nevada (“EDCR”) charges the Chief Judge of the Eighth Judicial District Court with various responsibilities, such as supervising the administrative business of the Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court’s duties are timely and orderly performed, and otherwise facilitating the business of the Court;

**WHEREAS**, for nearly two and one-half years, Department 14 has honorably served as a Specialty Courts department, overseeing the crucial mission that problem-solving courts carry out in the administration of justice, and the rotation of specialty dockets is a common judicial case management practice that helps foster diversity in judicial practice;

**WHEREAS**, Administrative Order 16-12 prescribes the circumstances under which hearing masters can oversee specialty courts matters, and Administrative Order 17-07 designated Melisa De La Garza as one of the Hearing Masters to preside over Specialty Courts.


