11 ORDER TO THE CLERK TO TRANSFER AND RANDOMLY REASSIGN ALL
12 "BAYCOL" CASES TO DEPARTMENTS 17, 18 AND 19

13 WHEREAS, on November 12, 2003, Judge Nancy Saitta, Chairman of the Complex Litigation
14 Team presented a petition to the Chief Judge during the regularly scheduled monthly Judge's meeting
15 to have all "Baycol" cases identified and reassigned to Departments 17, 18 and 19 for purposes of
16 providing single judicial supervision and improving management of said cases.

17 WHEREAS, on November 12, 2003, the District Court Judges for this district unanimously voted
18 to accept the proposal to have all "Baycol" cases randomly reassigned to Departments 17, Honorable
19 Judge Michael A. Cherry, 18, Honorable Judge Nancy M. Saitta, and 19 Honorable Judge Allan R. Earl.

20 IT IS HEREBY ORDERED that the Clerk of the Court for the Eighth Judicial District Court
21 transfer and randomly reassign in proportionate numbers, to Departments 17, 18 and 19, the cases
22 identified on the attached Exhibit 1. Any future cases filed with the Clerk of the Court that fit this criteria
23 will be randomly assigned to one of these departments. A minute order to conform with the language
24 of that attached as Exhibit 2, will be the appropriate method for the transfer of existing cases.
