IT IS HEREBY ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 1's entire criminal caseload shall be transferred to Department 14 and 800 open civil cases shall be drawn from the reassignment pool and transferred to Department 1;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 2's entire criminal caseload shall be transferred to Department 4 and 800 open civil cases shall be drawn from the reassignment pool and transferred to Department 2;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 700 cases aged 36 months or less from Department 4's open civil caseload, excluding medical malpractice cases, shall be-transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 700 cases aged 36 months or less from Department 14's open civil caseload, excluding medical malpractice cases, shall be transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 18's entire criminal caseload shall be transferred to Department 19;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 18's entire civil caseload shall be transferred to Department 24;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15),

that 300 cases aged 36 months or less from Department 19's open civil caseload, excluding medical malpractice cases, shall be transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that all cases designated as construction defect cases in Department 19 shall be transferred to Department 30 and Department 31 in accordance with "Exhibit 1";

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 24's entire civil and criminal caseload shall be transferred to Department 9 and 800 open civil cases shall be drawn from the reassignment pool and transferred to Department 24;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 200 cases aged 36 months or less from Department 26's open civil caseload, excluding medical malpractice cases, shall be transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 250 cases aged 36 months or less from Department 30's open civil caseload shall be transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that 250 cases aged 36 months or less from Department 31's open civil caseload shall be transferred to the reassignment pool;

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 4 shall replace Department 2 in Track 4 of the Criminal Caseflow Model.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 9 shall replace Department 24 in Track 2 of the Criminal Caseflow Model.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 14 shall replace Department 1 in the Rural Track of the Criminal Caseflow Model.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30 (14) and EDCR 1.30 (15), that Department 19 shall replace Department 18 in Track 3 of the Criminal Caseflow Model.

IT IS FURTHER ORDERED that an updated Criminal Caseflow Model shall be

attached to this order as "Exhibit 2."

IT IS FURTHER ORDERED that this Administrative Order shall supersede Administrative Order 14-04.

IT IS FURTHER ORDERED that court administration shall publish on the court website a list of those civil cases affected by the transfer no later than December 17, 2014.

IT IS FURTHER ORDERED that the aforementioned transfers and track changes shall take effect on January 5, 2015.
