WHEREAS, Rule 1.30(b) of the Rules of Practice for the Eighth Judicial District Court of the State of Nevada ("EDCR") charges the Chief Judge of the Eighth Judicial District Court ("Court") with various responsibilities, such as supervising the administrative business of the Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the Court's duties are timely and orderly performed, and otherwise facilitating the business of the Court;

WHEREAS, pursuant to Administrative Order 16-09, the Court reassigned all minor guardianship cases in which Soonhee Bailey was the designated hearing master to Department 27 and reassigned all minor guardianship cases in which Amy Mastin was the designated hearing master to the Chief Judge;

WHEREAS, pursuant to Administrative Order 17-01, all minor guardianship cases were reassigned to the Chief Judge effective January 30, 2017 on the condition that the long-term viability of the reassignment would be periodically evaluated under *Landreth v. Malik*, 127 Nev. 175 (2011);

WHEREAS, the aforementioned reassignment was motivated in part to temporarily assist the Family Division in fulfilling a critical need in minor guardianship adjudications; and,

WHEREAS, all existing minor guardianship cases have been reassigned to the Family Division.

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b) that all new minor guardianship cases shall be randomly assigned to judges in the Family Division that carry a minor guardianship caseload, consistently with the "one-judge-one-family" rule prescribed in NRS 3.025(3) and EDCR 5.103, effective immediately.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that Administrative Orders 16-09 and 17-01 are hereby superseded.
