Since it was determined that the abuse neglect/dependency juvenile judge's calendar would be a "full time" judge due to the blending of the State with the County workers; and

Based upon the fact that it was determined that the delinquency judge's calendar was determined to be a "part-time" judge position and that the presiding duties could be performed in tandem with this calendar; and

Further based upon the fact that these determinations regarding the time required to perform the two calendars was not researched at the time of being designated as "full-time" or "half-time; and

Since there will be yet another full judicial position added to the domestic calendars making a total of ten Family Division domestic judges; and

Due to the fact that the two juvenile judges have agreed to work with each through workload assignments and master assignments to reduce the calendar responsibilities from the current presiding judge so as not to interfere with his additional presiding duties and his "full-time" calendar;

IT IS HEREBY ORDERED, that pursuant to EDCR 1.30, the caseload redistribution currently being prepared by CMC shall stay in effect through December 31, 2003 and that the two juvenile judges work out any workload changes necessary so that the status quo of the past two years remain with the presiding judge duties and the juvenile court duties being accomplished within the juvenile division.
