SUBJECT: MEMBERSHIP DUES POLICY - EIGHTH JUDICIAL DISTRICT COURT

I. <u>PURPOSE</u>

The purpose of this policy is to set forth the procedures required to administer the membership dues policy in District Court.

II. AFFECTED EMPLOYEES

This policy applies to all employees of the Eighth Judicial District Court

III. PROCEDURES

Judges and Court Administrator - \$1,100 Limit

Judges and Court Administrator for the Eighth Judicial District Court are eligible for payment and/or reimbursement of dues for membership in judicially oriented professional organizations (one of which shall include the State Bar of Nevada) up to a maximum amount of \$1,000 per year.

Attorneys and Assistant Court Administrator - \$650 Limit

Attorneys and the Assistant Court Administrator for the Eighth Judicial District Court are eligible for payment and/or reimbursement of dues for membership in court oriented professional organizations up to a maximum amount of \$650 per year.

Managers and Analyst - \$450 Limit

Managers and Analyst for the Eighth Judicial District Court are eligible for payment and/or reimbursement of dues for membership in court oriented professional organizations up to a maximum amount of \$450 per year.
