CASE REASSIGNMENTS **Administrative Order: 26-02**

WHEREAS, the Chief Judge is responsible for supervising the administrative business of the Eighth Judicial District Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed, and otherwise facilitating the business of the Court; NRS 3.025; EDCR 1.30(b).

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b), that 50% of all civil cases currently assigned to Department 26 shall be reassigned to Department 12.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that all criminal and related civil cases, currently assigned Department 12, except for homicide cases and misdemeanor appeals, shall be reassigned to Department 26, and Department 26 shall replace Department 12 in LVJC Track 14 of the Criminal Case Flow Model.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that the aforementioned case reassignments and track change shall take effect on March 30, 2026.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that Court Administration shall publish the case reassignments affected by this order on the Court's website no later than March 29, 2026.
